Wisconsin regulators set rate adjustment for Superior Water, Light & Power

Superior, Wisconsin — The Public Service Commission of Wisconsin has approved adjustments to electric, natural gas and water rates for Superior Water, Light & Power, a wholly owned subsidiary of ALLETE Inc. (NYSE:ALE).

The Commission authorized an annual revenue increase for SWL&P of approximately \$5.5 million or 4.4%, which will result in a 1.4% increase in electric rates, a 15.6% increase in natural gas rates, and a 10.9% increase in water rates. The new rates are effective Jan. 1, 2025.

The rates approved Thursday support investments in infrastructure improvements, including replacing aging gas and water mains along Hammond Avenue in Superior, and the environmental remediation of a manufactured gas plant previously owned and operated by SWL&P. They also reflect higher operating costs because of inflation.

The rate adjustments on customer bills will vary depending on respective utility service schedule, rate, season and usage characteristics. The average residential customer of all three utilities using about 500 kilowatt hours of electricity, 75 therms of natural gas and 600 cubic feet of water will see a total change of about \$22 per month.

"These rate adjustments reflect the continued investments and upgrades to our systems, ensuring customers receive the safe and reliable electricity, natural gas and water services they depend on," said Rob Sandstrom, SWL&P president. "SWL&P recognizes the impact of this overall increase and reminds customers who may have difficulty paying their bill to contact our knowledgeable customer service team for assistance."

SWL&P filed an application with the PSCW in March 2024 for authority to adjust electric, gas and water rates. The PSCW is an independent authority that carefully considers multiple factors, including public input, during the review process and ultimately decides the final rates of each utility.
